

**REGULATION FOR SCUBA DIVING WITH DIVING IN ELBA**

- 1) Only divers with recognized certification can participate to the scuba activities.
- 2) The use of: jacket, two regulators or octopus, pressure gauge, depth gauge + clock + tables or computer, emergency signal buoy is mandatory as per the new regulation concerning the scuba activities in Italy.
- 3) The dive spot will be chosen by the Captain, depending on the sea conditions, and can be changed, at his discretion, even at the last moment.
- 4) The dive profile will be established by the guide, who will be responsible only to show you the way and not for the diving techniques of each individual participant. The guide will recommend to NEVER exceeding the depths allowed for your level and ALWAYS stay in the NO DECOMPRESSION LIMIT. MAX depth 40 Mt. (Mandatory limits by law).
- 5) Each participant must maintain close contact with the partner assigned (buddy system), visual contact with the guide and must be ready to interrupt the dive if the guide deems it appropriate.
- 6) Before embarking or disembarking it is MANDATORY to wait for the Captain's permission and in any case to be moored.
- 7) Do not jump into the water before the anchor has been completed and the engine switched off and only after the Captain has granted the authorization.
- 8) Do not take initiatives (for example, give up mooring lines, lower the ladder, etc.) without having received authorization from the Captain of the boat.
- 9) In case of emergency it is mandatory to submit to all orders given by the Captain.
- 10) IT IS ABSOLUTELY FORBIDDEN TO CARRY ANY KIND OF MARINE LIFE FROM THE BOTTOM, SHELLS AND HOW OTHER IS NOT TRASH.
- 11) DIVING in ELBA snc is not liable for any theft or damage to objects left unattended at its centers or on board.
- 12) In the case of technical-logistical support to a pre-established group, the activities pass under the direct responsibility of the Instructor leader of the group, even if the DIVING in ELBA provides the GUIDE service.

- e) To be fully aware of the DIVING IN ELBA regulations (see above), of the topics concerning safety, prevention and medical emergencies related to diving (included all procedures concerning COVID-19 emergency).
- f) To be able to communicate during SCUBA diving with conventional signals and to know how to manage my dives independently.
- g) I am responsible for all the equipment I rented. This equipment works properly and in case of damage or loss I will refund the dive center with an amount equal to the total value.
- h) I have understood and approved the "REGULATION" above in all the 12 (twelve) points. What I have declared is true. I know the terms of this document have contractual value and I sign on my free initiative.
